## **Customer Information | REACH Regulation**

Regulation (EC) No 1907/2006 (REACH) is the European Union Regulation on the tracking of chemicals and notification to relevant stakeholders to ensure their safe use. It deals with the Registration, Evaluation, Authorisation and Restriction of Chemical substances. The candidate list of Substances of Very High Concern (SVHC), which needs to be tracked, was first published on 28 October 2008 and is regularly updated.

REACH requires Sharp NEC Display Solutions Europe GmbH to provide customers with sufficient information on SVHC when contained in articles or products in a concentration above 0.1% weight-by-weight (w/w).

Considering the recent version of the candidate list and the information collected throughout our supply chain these products may contain SVHC above the allowed threshold.
